General Information

This agreement is a 12-month minimum commitment and is billed monthly. This contract shall commence on the date executed and payment received. The Monthly Fee will be charged initially as a prorated amount based upon the days left in the month; then on the first day of the month for the current months privileges and each month thereafter, until this contract has been cancelled by either party. The 12 month commitment is waived for all members in good standing as of 12/31/2023.

General Information (continued)

The monthly fee will continue to be charged after the 12-month minimum commitment has been met, unless written/email notice of cancellation is received 30 days in advance of the next billing date [i.e. last day of the month].

The Member agrees to maintain a current credit card and Bank Account in the Member's name on file with the Club. Any changes of information must be reported to Waterford Golf Club immediately. The credit card on file or Bank Draft Information will be charged on the first day of each month for the current month's dues. A 3% convenience fee shall be added for all members utilizing a credit card for monthly billing. There is no added fees for ACH transactions.

Golf Cart Requirements

Walking is available anytime Monday-Friday year round. Carts are required on Saturdays, Sundays, and Holidays until 2pm April through October and until 12pm November – March. No private golf carts are allowed. Must have valid driver's license to operate golf cart Payment or golf carts must be made in advance to play. Members are responsible for damage to club owned golf carts caused by misuse or an accident by the member while renting the cart.

Privileges

Upon payment of the required Entrance Fee, monthly dues and other applicable charges, Members are entitled to use Waterford's' Golf Facilities and Clubhouse. Members do not pay green fees for use of the golf course but are required to pay golf cart rental fees and fees for other services as applicable.

Resignation of Membership

A Member may resign from Membership by giving thirty (30) days written notice of resignation to the Waterford General Manager, whereupon the Membership shall terminate once all outstanding dues and charges are paid in full. In the event of resignation, the member is not entitled to a refund of any portion of the Entrance Fee, monthly/annual dues or other charges that are outstanding or accrued as of the date of resignation. Membership may not be reinstated for a period of 12 months after resignation date.

Suspension or Termination for Cause

Any Membership may be suspended or terminated, and the Member expelled from Waterford for non-payment of dues, fees, or other charges, for violation of the Membership Rules, or for other cause as determined by management. Management will provide written documentation to the Member as appropriate. In the event of a termination for cause or resignation during a suspension period, the member is not entitled to a refund of any portion of the Entrance Fee, monthly/annual dues, or other charges.

Summary of Membership Status

Membership in Waterford constitutes a revocable license to use the facilities but does not give the member a vested or prescriptive right or easement to use the facilities. Membership is not an investment in the facilities and does not provide an equity or ownership interest in the LLC or the on-site facilities. All membership privileges may be modified from time to time or terminated by the Owner at its sole discretion.
